

ATTESTATION

I do hereby solemnly certify and attest:

1. I have carefully read and fully understand the Camp Northland B'nai Brith Summer 2022 Covid requirements and protocols at <https://www.campnbb.com/summer2022> (hereinafter, the "2022 Covid Protocols").
2. My household, and each other household at which our camper(s) have resided in the 7 day period prior to the commencement of camp, have carefully followed and abided by the Camp's 2022 Covid Protocols and each of the requirements set out therein, and will continue to do so until such time as the camper(s) in our family have safely arrived at Camp.
3. No member of our household(s) has been directed by any Public Health authority to self-isolate in the 14-day period prior to the commencement of Camp.
4. No member of our household(s) has tested positive for Covid-19, experienced symptoms of Covid-19, or been in close proximity with any person who has tested positive for Covid-19 in the 14-day period prior to the commencement of Camp. I will advise the Camp promptly if there are any changes in this regard prior to the commencement of Camp.
5. All members of our household(s) have limited their exposures (i.e. reduced the chances of becoming infected by limiting contact with individuals outside their immediate household) to the greatest extent possible in the 7 days prior to the commencement of Camp.
6. My household, and each other household at which our camper(s) have resided in the 7 day period prior to the commencement of Camp have fully abided by the Camp's 2022 Covid Protocols. I specifically attest on behalf of all such households that our camper(s) and all other family members and residents in each such household at which our camper(s) have resided or will reside in the 7 day period immediately prior to the commencement of Camp, have at least complied with the following:
 - Avoiding indoor and large-scale events (i.e. dance recitals, birthday parties, weddings, play dates, indoor dining, etc.)
 - All household members minimized interaction with those outside their home (interactions should be outdoors or masked indoors if necessary)
 - Wearing a 3-ply, tight fitting surgical quality mask (or preferably N95) indoors outside of immediate family/household (including school)
 - Physical distancing where possible and practical to do so
 - Limiting the number of visitors to our household(s), have kept all such visits short, and have utilized masks, a properly fitted surgical tight fitting or N95 mask, and maintained safe distance in all such circumstances;

and we will continue to do so until the safe arrival of our camper(s) at Camp.

7. I will immediately notify the Camp office of any past or future departure(s) by our household(s), however minor, from the Camp's 2022 Covid Protocols.
8. I acknowledge the responsibility of each Camp family and household, including ours, to truly minimize possible exposures to Covid-19 before our camper(s) enter Camp. I understand that any material omission, misrepresentation or false statement in this attestation could have legal and other consequences for me and I accept all such consequences.
9. I authorize the camp's medical team to verify submitted documentation and/or results related to testing and covid vaccinations. This may include contacting physicians, health care providers, on-line portal submissions, the 'Covax' system, or others as may be required to achieve this purpose.
10. I acknowledge and understand that IC (In-Common) Labs will be providing results of covid PCR testing to the camp and that the camp will only notify the family of only positive covid test results once results are received. If a family would like a copy of any results, a request can be made in writing to happycamper@campnbb.com or to the lab directly.
11. I make this attestation with the intention and understanding that it shall be treated as a binding legal document as if I have executed it under oath or affirmation.
