

## **ATTESTATION - STAFF**

I do hereby solemnly certify and attest:

1. I have carefully read and fully understand the Camp Northland B'nai Brith Summer 2022 Covid requirements and protocols at <https://www.campnbb.com/summer2022> (hereinafter, the "2022 Covid Protocols").
2. Every household in which I have resided in the 14-day period prior to the commencement of Camp (or any reduced timelines as may be communicated in the camp's 'Road to Camp' communications for summer 2022), has carefully followed and abided by the Camp's 2022 Covid Protocols and each of the requirements set out therein, and will continue to do so until such time as I have safely arrived at Camp.
3. No member of any household(s) in which I have resided in the 14-day period prior to the commencement of Camp (or any reduced timelines as may be communicated in the camp's 'Road to Camp' communications for summer 2022) has been directed by any Public Health authority to self-isolate in the 14-day period prior to the commencement of Camp.
4. No member of any household(s) in which I have resided in the 14-day period prior to the commencement of Camp (or any reduced timelines as may be communicated in the camp's 'Road to Camp' communications for summer 2022) has tested positive for Covid-19, experienced symptoms of Covid-19, or been in close proximity with any person who has tested positive for Covid-19 in the 14-day period prior to the commencement of Camp (or any reduced timelines as may be communicated in the camp's 'Road to Camp' communications for summer 2022). I will advise the Camp promptly if there are any changes in this regard prior to the commencement of Camp.
5. All member of any household(s) in which I have resided in the 14-day period prior to the commencement of Camp (or any reduced timelines as may be communicated in the camp's 'Road to Camp' communications for summer 2022) have limited their exposures (i.e. reduced the chances of becoming infected by limiting contact with individuals outside their immediate household) to the greatest extent possible in the 14 days prior to the commencement of Camp (or any reduced timelines as may be communicated in the camp's 'Road to Camp' communications for summer 2022).
6. Each member of every household at which I have resided in the 14-day period prior to the commencement of Camp (or any reduced timelines as may be communicated in the camp's 'Road to Camp' communications for summer 2022) has fully abided by the Camp's 2022 Covid Protocols, including the isolation requirements. I specifically attest that all members of each household at which I have resided or will reside in the 14-day period immediately prior to the commencement of Camp (or any reduced timelines as may be communicated in the camp's 'Road to Camp' communications for summer 2022), have:
  - a. Made reasonable and good faith efforts to isolate and remain home where possible and as required by the 2022 Covid Protocols, except for essential reasons (which may include school and work), subject to 6(b) below;

- b. Where departure from home has been unavoidable for essential or critical reasons, we have followed strict public health guidance, including proper wearing of PPE, including a properly fitted N95 face mask, physical distancing at all times and remaining outside whenever possible, and followed recommended hygiene and hand sanitization practices;
- c. Limited the number of visitors to our household(s), have kept all such visits short, and have utilized masks, a properly fitted N95, and maintained safe distance in all such circumstances;
- d. Avoided contact with others, and in particular, contact with any high-risk groups;
- e. Avoid potential super spreader events such as concerts, indoor sporting events or similar venues.

and we will continue to do so until my safe arrival at Camp.

- 7. I will immediately notify the Camp office of any past or future departure(s) by any member of my household(s), however minor, from the Camp's 2022 Covid Protocols.
- 8. I acknowledge the responsibility of each Camp staff member and all Camp families and households, including my own, to truly minimize possible exposures to Covid-19 before our entry into Camp. I understand that any material omission, misrepresentation or false statement in this attestation could have legal and other consequences for me and I accept all such consequences.
- 9. I make this attestation with the intention and understanding that it shall be treated as a binding legal document as if I have executed it under oath or affirmation.
