(iii) such nomination was received by the Corporation at least ten (10) days prior to the Annual Meeting of the Members at which the election is to occur; and
(iv) such nomination includes a biographical description of the proposed nominee(s), not to exceed one $81 / 2^{\prime \prime} \times 11^{\prime \prime}$ page in length.

## For election of Officers, the new bylaws (paragraph 6.03 section "e") state as follows:

Officers shall be elected by the Members from among the candidates duly nominated therefor by the Nominating Committee or on petition of ten (10) Members; provided that in respect of a nomination made by Members:
(i) each such nomination shall be in writing and accompanied by the written consent of the nominee;
